Introduction

The initiative “**Resource Sharing in the Times of COVID-19**” (RSCVD) was launched by the IFLA DDRS Committee to help libraries during the pandemic emergency. Italian volunteering librarians provide materials to libraries worldwide and act through an account denominated **CBN Virtual Library** created in **NILDE** (Network for Inter-Library Document Exchange) as an intermediary between borrowing libraries in RSCVD and lending libraries in NILDE. The documents are delivered via a secure delivery system (GARR File Sender).

Declared identity of the providing libraries (lending) and borrowing libraries

> CHECK of the papers or books requests in RSCVD Google Drive Sheet

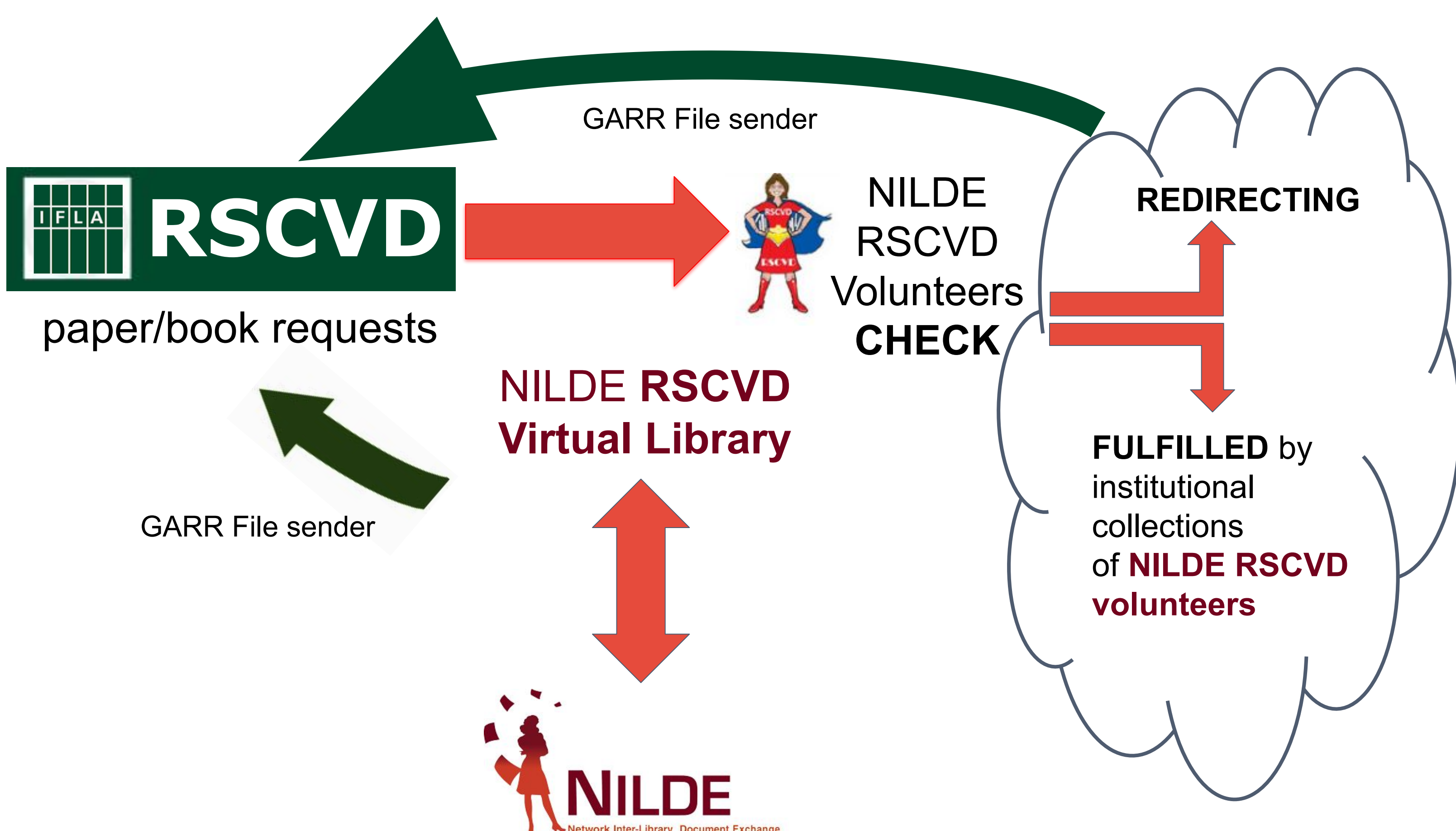
> DOCUMENT DELIVERY

- 1) Search library suppliers and holdings in catalogues (ACNP, SBN, Worldcat, discovery tools)
- 2) Deliver of papers requested in RSCVD through GARR file sender (retrieved in our institution libraries or in the NILDE network from library lenders)

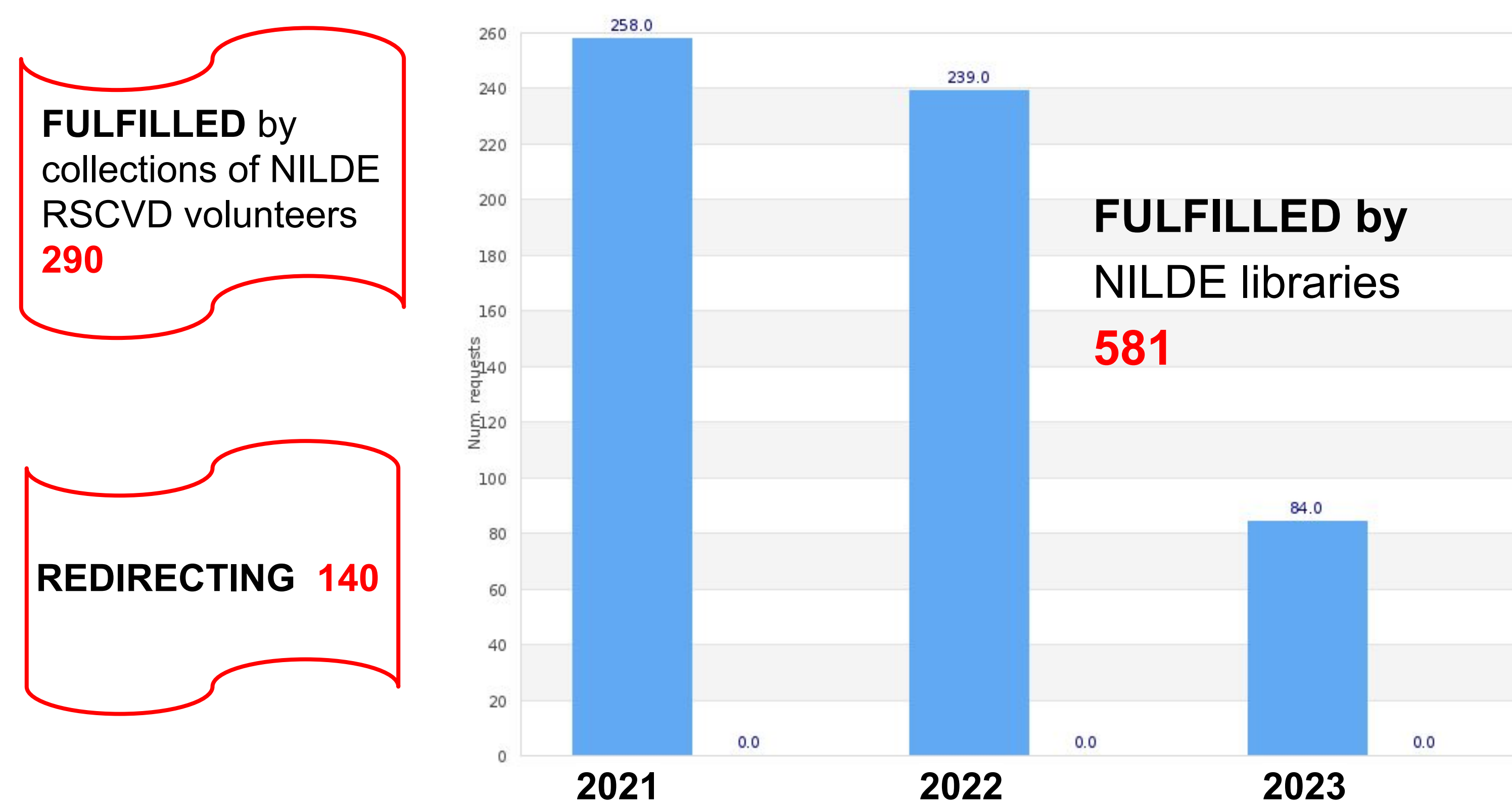
> REDIRECTING

Direct e-mail messages with information about documents available on line in open access or as free content in digital libraries or through digital lending (for example Book to borrow, Archive.org, or public repositories and other public domain sources).

Open problems: wrong or incomplete references; unchangeable request data; removal of “in process” requests due to RSCVD Google drive update.



Results 02/2021-03/2023



Total fulfilled requests: 1011

Benefits: international networking, appreciation and awareness of the advantages of the resource sharing, growth of problem solving abilities and skills, equal and inclusive, green and sustainable service, global access to information without borders, connecting libraries globally, dissemination of knowledge.

Criticalities: unsuccessful research of electronic documents, embargo and copyright limits, lack of awareness of the digital potential and advantages, needs of improving e-lending knowledge, need for a stable, organized and free global resource sharing platform, persisting limits to equal access to knowledge.

Suggestions:

- increase professional training
- share collections worldwide for strengthening and empowering local and regional cooperation
- creation of a global, stable, organized and free resource sharing system

Conclusion

Since it is impossible for a library to collect all the materials needed by their patrons, ILL-DD is one of the most important services that a library can offer to their patrons. The RSCVD initiative allows for a fast, free and equal retrieve of materials not available in existing borrowing systems and builds a bridge between library regional networks and worldwide resource sharing systems, overcoming geographical limits and customs barriers. The RSCVD lesson shows that we can meet, exchange and learn from each other and that “Libraries have an indispensable role in building and strengthening democracy around the world” (IFLA, WLIC 2019. Libraries, Access to Information and democracy).
